

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.arrowsdownmassage.com and Arrows Down Massage Therapy and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Arrows Down Massage Therapy include www.arrowsdownmassage.com and Arrows Down. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Arrows Down may collect personally identifiable information, such as your:
